WHAT IS KEEPOUT THE CRIME DIVERSION SCHEME?

KeepOut – the Crime Diversion Scheme (Registered Charity No 1097124) is unique in that it is managed by our staff but delivered by dedicated teams of Category C male prisoners at HMP Coldingley in Bisley, Surrey, and female prisoners at HMP Send near Ripley, Surrey.

The Scheme was started in 1996 by a prisoner nearing the end of his life sentence. It was created with the aim of informing and supporting young people. Every year the Scheme works with around 1,300 young people from across the south east aged between 13-17 (inclusive) at HMP Coldingley and 14-17 (inclusive) at HMP Send.

There are two main drivers that the Scheme works to:

- the prevention of crime amongst young people
- the rehabilitation of offenders

The majority of young people attending the Scheme have been identified as being at risk of offending. Many of those who visit the Scheme and attend its workshops are already committing offences and are known to police, youth offending teams and courts. A smaller percentage of young people are referred to the Scheme as a last step measure before a custodial sentence is enforced.

For the young people attending the Scheme it is a wake-up call to a possible road that lies ahead for them. The workshops demonstrate the harsh reality of prison life and prisoners give a detailed account of how they ended up inside. Young people take part in a range of interactive and creative exercises and discussions, aimed at helping them to choose a life without crime. The aim of the session is to show young people the reality of crime and the consequences for them, their families and the victims.

HOW ARE PRISONERS INVOLVED IN THE SCHEME?

The unique part of the Scheme is that it is the prisoners themselves who work with the young people. The benefits for the prisoners are enormous; they gain valuable skills and may receive recognised NVQ qualifications that could hold real value when seeking paid employment after release. Prisoners experience an excellent opportunity to break the cycle of offending by giving back to society through this unique set of interventions.

The Scheme allows prisoners to develop their communication, creative and interpersonal skills through facilitating the events for young people. The Scheme also helps prisoners to develop self-esteem, self-confidence and for many it provides direction in life for the first time. The Scheme itself allows prisoners to rehabilitate as they guide and advise the young people against making the same choices they did.

WHAT SERVICE DOES KEEPOUT OFFER?

It is a service based on a tried and tested model of delivery, and a recognised example of effective partnership into practice. The Scheme offers a weekly programme of one-day workshops targeted at young people who are either in the criminal justice system or at risk of entering it. The partnership is enhanced by the involvement and support of Surrey Youth Justice Service, which assists in the training and development of prisoners involved in the delivery of a sequence of workshop programmes.

The prisoner team, KeepOut paid staff, Surrey Youth Justice staff, training providers and user group leaders all work together. Collaboratively, they provide a responsive service, tailored to meet the varying needs of those young people who attend.

Each week the Scheme offers one-day interactive workshops inside prison, which are delivered by the prisoner team with the support of the KeepOut paid staff.

The programme we offer is aimed at young people who are already engaged in a programme of intervention or prevention. The visit to the prison should be part of a planned programme of learning – we give priority to these groups.

We ask that young people should not have attended a KeepOut event in the past.

Before they apply to attend a workshop, , **we require group leaders to carry out a needs assessment based on the behaviours of their young people** and list them on the application form, indicating whether they are low, medium or high risk. This enables the Operations Manager to steer the group to the workshop that provides the most appropriate level of intervention. This also provides the prisoner team with shared information they can use to customise the programme and make it more fit for purpose.

WHAT ARE THE WORKSHOP OPTIONS THAT THE SCHEME CAN OFFER TO MEET THE BEHAVIOUR NEEDS OF YOUNG PEOPLE?

Option 1 – Who is this workshop aimed at?

Aimed at young people whose behaviour needs have been assessed as low risk, who require **short term standard intervention, information and guidance**.

What can those who attend this workshop event expect?

The programme for the day focuses on three main areas:

- personal responsibility
- victim empathy
- consequences of their behaviour.

Prisoners share their life experiences in personal testimonies. Participative interactive activities and discussions are held between the prisoner team and young people

What are the expected outcomes?

- Demonstrates to young people the harsh realities of a life of crime and the consequences to them, their families and victims
- Young people learn from experienced adults the effect of their behaviours on others
- Confronts them with the penalties they face if they decide to be involved in anti-social or offending activities
- Allows them to discover alternative ways to avoid becoming involved in unacceptable behaviours

Option 2 – Who is this workshop aimed at?

Aimed at those young people whose behaviour needs have been assessed as medium risk who are disengaged and require **enhanced intervention, information and guidance**.

What can be included in this workshop?

The event can be tailored around specific issues identified through the needs assessment.

The following are some areas that can be covered:

- alcohol misuse and alcohol prevention
- participation in gangs and gang culture
- offensive weapons
- anti-social behaviour
- vehicle crime
- sexual exploitation
- domestic violence.

Prisoners use personal experiences in presenting to the young people. Some of these young people learn for the first time the consequences of their behaviours. The workshop aims to provide them with accurate information, so they can make more informed choices about the activities in which they participate and how to KeepOut!

What are the expected outcomes?

- Enables young people to take stock of their offending behaviours and the potential consequences to both themselves, their peers, families and the wider community
- Encourages them to be more responsible individuals within the society in which they live
- Delivers more understanding of the implications of being involved in certain activities
- Signposts them to ways of not getting involved in specific activities that can lead to offending.

Option 3 - Who would this course be offered to?

Aimed at young people with multiple problems who **require intensive intervention and sustained support**, who are middle to high risk and have committed a serious offence.

The Scheme is not offering these courses at present but can develop exclusive offending behaviour programmes to specific groups over an agreed period of time.

These provide an even higher level of intervention and can:

- reinforce the core messages identified in workshops 1 and 2
- customise specific elements of the programme to focus on identified needs of the overall group and the individuals within it.

What are the expected outcomes?

- Gives young people a longer period of time to reflect
- Enables them to develop and revisit issues raised in the sessions
- Provides leaders and young people with an opportunity to develop an agreed action plan that can be reviewed and revisited
- Hopefully diverts young people from either continuing to commit crime or re-entering criminal justice system
- Motivates them to participate in society as mature and responsible citizens.

HOW DOES THE SCHEME WORK TOGETHER WITH THE SURREY YOUTH JUSTICE SERVICE (SYJS)?

Within this framework, the KeepOut prisoner teams also work in two Surrey prisons assisting Surrey Youth Justice Service in the delivery of its programmes. This includes the CAN DO programme, aimed at young people with serious and persistent offending and who present a high risk of harm and re-offending. Referrals for this group are through SYJS staff only.

Confidentiality is assured within the following guidelines:

- Personal information regarding prisoners and young people is confidential to the KeepOut team, not the individual
- Personal information may be shared with the KeepOut Operations Manager for support and guidance when required
- Personal information will only be shared with other agencies after written consent forms are signed
- Written notes on young people are to be kept in a locked cabinet and available for the review of the KeepOut staff team and the young person only. .

Confidentiality will only be broken when

- There is a risk of serious harm to self or others
- There is a suspicion or information of harm to young people
- There has been, or is likely to be, a breach of prison security
- A client discloses detailed incriminating information concerning a current or past serious offence that has not been reported previously to the police.

A copy of the KeepOut Confidentiality Policy is fully explained at the beginning of each event. (Annex A)

WHAT IS REQUIRED FROM USER GROUPS BEFORE THEY ATTEND AN EVENT?

Before you bring a group to a KeepOut event, one member of your accompanying staff must have previously attended an Adult Showcase event. These are run when required 10.00–1200 hours at HMP Send; attendees need to arrive at 9.45 for security checks. They give an overview of the event with explanations and demonstrations of exercises and techniques used.

HOW SHOULD GROUP LEADERS PREPARE YOUNG PEOPLE BEFORE AN EVENT?

To ensure young people gain as much benefit as possible from their visit, they should be involved in a preparation session before attending an event. A pre-event questionnaire (Annex B) should be completed by all young people. These should be handed to a KeepOut member of staff by your Group Leader at the beginning of an event.

At the end of an event a post-event questionnaire (Annex C) should be completed by each young person.

KeepOut reserves the right to refuse future bookings if your organisation fails to comply with appropriate preparation and evaluation sessions.

WHAT IS THE BOOKING PROCEDURE FOR ATTENDING AN EVENT?

To book to attend an event, please follow this procedure:

- a.** Your organisation ensures a member of staff accompanying a group has previously attended a KeepOut Adult Showcase event (*see above*).
- b.** Your organisation emails the Event Request Form (Annex E) to the KeepOut Operations Manager, mary.wethey@crimediversionscheme.org.uk. This form also confirms that all accompanying members of staff have a current enhanced Criminal Records Bureau (CRB) check.
 - Events at HMP Send are held on a Monday or Tuesday. On the Event Request Form please suggest two or three dates that you can attend, preferably six weeks in advance.
 - Please can you add into the background information on the Event Request Form a) how many young people will be attending b) how many adults will be attending.
- c.** The KeepOut Operations Manager sends a confirmation email to your organisation and requests information for a Police National Computer (PNC) check from all staff attending an event.
- d.** Police National Computer (PNC) check details are forwarded to the KeepOut Operations Manager.
- e.** Your organisation obtains parental/guardian consent for all young people due to attend an event (Annex F).
- f.** Your organisation conducts a pre-event session with all young people due to attend an event – this must include the distribution and discussion of the Notice to young people (Annex G).
- g.** One week before attending the event your organisation must complete and forward the Attendance list (Annex H) to the KeepOut Operations Manager by email.
- h.** On the day of the event your group are to arrive at HMP Send at 10:00 hours where a KeepOut member of staff will greet you at the entrance. Copies of the Pre-event questionnaires are to be handed to the KeepOut member of staff. KeepOut is a day long event finishing at 3.15pm.

- i. All adults must bring photo ID such as a passport or driving licence to gain admittance to the prison.
- j. Group leaders are to ensure that all valuables including money, mobile telephones and hand bags are taken from the young people and locked in a group leaders vehicle prior to entering the prison.
- k. Everyone entering HMP Send will be searched and anyone carrying prohibited items (Annex G) may be refused entry. On occasions, the security staff will be on duty with their dogs to check for possession of drugs.
- l. In the event of an incident which may delay the arrival of your group, the Group Leader is asked to contact HMP Send on 01483 471000.

WHO IS RESPONSIBLE FOR THE BEHAVIOUR OF A GROUP ATTENDING AN EVENT?

Group Leaders and accompanying workers have full responsibility at all times for the behaviour and conduct of their group. The supervision and management of the group is your responsibility within the prison compound, the car park area as well as when you have been admitted to the main prison premises. If the behaviour of the group is inappropriate, the group can be refused entry to the prison or be asked to leave. It is extremely important that all groups comply with this aspect of the Scheme's criteria.

WHAT DO GROUPS NEED TO PROVIDE FOR LUNCH?

Coffee, tea and soft drinks are provided by KeepOut. You are advised to bring lunch for each person. Sandwiches must have been purchased and in sealed packaging, i.e. not home made. No fruit, drinks, crisps or foil

WHAT IS THE DRESS CODE FOR ATTENDING AN EVENT?

Please ensure all young people in your group are modestly dressed. School uniform is not appropriate for any young person attending an event. No hoods or hats are to be worn.

If an incident dictates that the Scheme has to cancel an event, a member of staff will contact the Group Leader as soon as possible to inform them of the cancellation and to rearrange the visit. Events will only be cancelled as a last resort.

If an organisation cannot attend an event due to unforeseen circumstances, the Group Leader is requested to contact the Operations Manager as soon as possible to inform them of the cancellation and to rearrange the visit where possible.

Notice to young people attending the KeepOut Scheme

While you are visiting KeepOut at HMP Send you will be expected to conform to the Prison Security Regulations. The rules that affect you are

1. No chewing gum
2. No mobile phones or pagers
3. No cameras
4. No cigarettes or tobacco, lighters or matches
5. No drugs or alcohol (*prescription medication should be given to your Group Leader who will notify the KeepOut staff of your needs*)
6. No weapons/scissors, nail files,
7. No hats or hoods to be worn
8. No foil
9. Sandwiches must have been purchased and in sealed packaging, i.e. not home-made or in foil
10. No fruit, drinks or crisps
11. No money

While you are in the prison you will be our guest and your behaviour will reflect on us. Please be polite and co-operative to the prison staff who are doing their job to ensure your safety.
